Dear Mr O Grady,

I write in response to e-mail correspondence received from Fergal Callaghan of AWN Consulting dated 05/09/2017 issued on your behalf in relation to a proposed technical amendment request of licence Reg. No. P0057-03.

Irish Water is satisfied to support your proposal to increase the Total Dissolved Solids (TDS) Emission Limit Value (ELV) as set out in *Schedule B.3 Emissions to Sewer* of licence P0057-03 from 25,000 mg/l to 50,000 mg/l to reflect the sodium component of the TDS subject to the following:

Note 1 as set out in Schedule B.3 shall be amended to read:

Note 1: Chloride discharges up to 25,000 mg/l shall be permitted between 07:00- 09:00 & 17:00-20:00; a maximum concentration of 10,000 mg/l shall apply at all other times.

A further Note 2 shall also be included in Schedule B.3 in relation to Total Dissolved Solids and shall read as follows:

Note 2: Total Dissolved Solids discharges up to 50,000 mg/l shall be permitted between 07:00- 09:00 & 17:00-20:00; a maximum concentration of 20,000 mg/l shall apply at all other times.

Irish Water also notes your agreement to complete a survey of the pipeline that may be affected by this discharge, with a view to Kingspan remediating any damage that may be caused, to keep the pipeline operational. However the full scope of the survey needs to be agreed with Denise McManus who is the regional contact for underground assets.

Please note that it is your responsibility to agree the scope (including extent, frequency and formats of outputs) with Ms McManus, or her nominee on behalf of Irish Water, prior to completion of any works.

As usual, Irish Water will work with Kingspan to make the request as reasonable as possible. In this case, it is in both parties interests to maintain service through this proactive surveying of the Infrastructure.
