The local lobster fishermen have contributed substantial financial resources over many years to restocking the lobster supplies in the surrounding coastal areas of Sligo, Leitrim, Donegal and Mayo. The larvae of lobsters, crab and prawns are very susceptible to damage and death from exposure to heavy metals especially copper. Up to 100 lobstermen derive livelihoods from lobster fishing in this catchment area.

Please be cognisant of these facts before releasing any substances into Sligo Bay.
