- Applicant has stated that the final use for poultry litter removed from the facility will be both composting and landspreading. If landspreading, applicant shall submit details of recipient farms including address, herd number and the relevant nutrient management plan demonstrating the crop nutrient requirement. In the case of compost facilities applicant shall submit signed agreement from the compost facilities that they will accept poultry litter from this facility and quantities per annum.
