Hi Ciara.

I've read over the NIS document and supporting Appendix provided. The authors identify all of the likely risks that present and come to solid conclusions as to the extent the risk posed to the Natura features identified. Specifically, the risk of distribution of fragments of the Carpet Sea Squirt (Didemnum vexillum) beyond the bounds of the marina and dredge area is presented as **high**; however, the risk of successful recruitment/reattachment is considered low, particularly if the timing of the dredging coincides with the lowest water temperatures experienced at the site (i.e. winter months). What is noteworthy in the report is there is no estimate or monitoring information provided as to the current extent of D. vexillum in the Marina area, and specifically the areas subject to dredging. This information would certainly allow greater certainty to apply to the risk assessment. Notwithstanding, it appears the view taken is highly precautionary and Consent of copyright owner required for any other conservative, i.e., that D. vexillum is extensively distributed throughout the marina. On this basis, I agree with the conclusion that the project as proposed (including mitigation measures to dredge in winter months only) does not present a risk to the habitats and species in adjacent Natura sites.
