RE: Proposed factory extension at Rossmore Industrial Estate for Norbrook Laboratories Ltd.

**Traffic Statement** 

The extension consists of a new packaging area, canopy and canteen / kitchen.

The packaging area is as a result of new export customer to the continent which requires separate facilities.

In relation to the TTA we would point out that due to the nature of the process there are only a maximum of 3 deliveries per day and the production involves small packages which have minimal transport requirements. The new packaging room is for a new line of veterinary product for a new export market. We hope that this additional information would negate the need for a full traffic and transport assessment (TA).

The canopy is required to give cover to the product packaging.

The existing canteen facilities are inadequate and the proposal involves upgrading toilet and washing facilities and a new canteen kitchen area.

The present working hours and staff numbers will remain unchanged.

The replacement car parking due to relocation of spaces is provided on site.

The proposal therefore will not result in an increase in either commercial vehicles or private cars.

## **Existing vegetation**

The existing vegetation will be maintained along the eastern boundary during and after construction

The area of vegetation on the western boundary in front of the proposed canteen is limited and in poor state. It is proposed this area of vegetation would be removed.

## Colour of Proposed Building

The colour of the cladding on the Eastern elevation will match existing for visual continuity.

Re: Making of Application to the EPA seeking an Industrial Emissions Licence under Class 5.16 - Norbrook Manufacturing (Ireland) Ltd, Rossmore Industrial Estate, Monaghan, Co Monaghan.

Dear Sir,

In relation to the above mentioned application I wish to confirm that serious concerns are now being expressed by the residents of this locality in regard to actual nature of on-site processing which is presently taking place by Norbrook industries. The original grant of planning consent was for the creation of a warehouse facility only but referring to image enclosed there is visual evidence in the form of both roof vents & exhaust flue that operations are clearly giving rise to the most fundamental issue of unauthorised emissions being generated from plant even though no licence has been issued by ERA insofar as residential community has been informed. There is also widespread expectation that extended work practices are going to be introduced shortly with hours of operation being increased from 9am-5pm to 6am-10pm to boost production rate which is further proof that some degree of on-site manufacturing & processing will take place. The particular facility is located in close proximity to an established residential area as well as MUFC's local soccer pitches that are used by countless number of children on a regular basis. The primary consideration here is to ensure that appropriate action is taken so as to safeguard public health above all else because the potential risk of a chemical contamination associated with either the release and/or escape of intermediate pharmaceutical by-products directly into the surrounding atmosphere cannot be countenanced under any circumstances in this instance. One final point worthy of mention is that the added services of an independent environmental expert may need to be engaged to execute a forensic investigation in order to ascertain what is being carried out within Norbrook Industries local premises as a matter of the utmost urgency.
