We refer to your letter dated 21 May 2019. As you know, we act for Gallagher Brothers & Ocean Farm Ltd. in connection with their objection to the proposed site A sought under application S0028-01.

We note that on 20 May 2019 the EPA determined that the Proposed Project, individually or in combination with other plans or projects, is likely to have a significant effect on a European site(s) and that the EPA now intends to carry out an Appropriate Assessment of the Proposed Project.

This determination accords with our client's concerns regarding the adverse impact of the Proposed Project on the environment and ecology of Donegal Bay if dumping is permitted at the marine disposal site A, which is only 6km south of Carrigan Head, Co. Donegal. Those concerns were previously set out in detail in our written submissions on behalf of our client to the Agency, arising inter alia from the uncertainty about the cause of catastrophic fish losses from previous dumping of dredged materials in the area.

We note that the disposal site approved by the EPA in Dumping at Sea Permit Reg. No. S0023-01, granted on 20 May 2019 to Sligo County Council, authorises the loading and dumping at sea of
