Dear Grainne,

I suppose it may well be a good idea for the many people interested in this Application to know that submissions can still be received by you (and I see one more went up on the website last night) and that the Inspector may also be willing to make some time available for us to respond to the currently outstanding replies from Irish Water and the Developer, in which case, please put this correspondence up on the website as a submission.

My query below to the Inspector concerned whether we should have cut short the tidal current measurements we are making with the help of BIM, in order to try and comply with what might have been the cut-off point she had set for Irish Water of today (one month from 24th December).

The technical advice on this that we had received earlier from our own consulting hydrographer was:

"A full tidal cycle is usually about two weeks. I would advise keeping the ADCPs deployed a long as possible. The more tidal cycles that have been observed the better".

The re-availability of the meters was outside of our control, but they were brought back from Dublin and put out on the 9th January. This is certainly quite a significant exercise and a pity to take short-cuts as the ADCPs weigh a few hundred kg and require lifting gear off the truck and onto and off the boat, so they are quite a major effort to bring down and to deploy. The Inspector agreed with me that it was best to do the job as best we could and not cut the tidal cycle short and that, as she was also planning to allow comments to be made on any replies received, we should make the best scientific measurements we could without today's time constraint.

Thus we are in fact only lifting the meters out of the sea today after the full 14 days and so will hopefully have the data on Monday, and I am hoping to submit the findings by the end of next week, before I go on holiday [REDACTED]. If I can then be given a few days after I get back to respond to any replies we may get, I should be very grateful.

I trust all of this is acceptable to yourselves.

Thank you very much for this advice. Orla indicated that we would probably have some time to respond to any replies put up by Irish Water and the Developer and we would be very grateful for that.

If these replies come by one month after 24th December, I will hope to have a few days to get something to you before I go on holiday – unfortunately booked [REDACTED] [REDACTED] some time ago.

In the meantime we have been running a further full 2 week tidal cycle measurement of current speeds and hence overall movement of water in the North Channel and are not fore-shortening the period to fit in with a 24th Jan. cut-off, a decision which Orla appeared to be happy with if there will be some leeway available for further comment on this Application.
