Notification under Section 87 (1E) (a) of the EPA Act 1992 - Declan Connolly

A Chara,

I refer to correspondence dated 19th June 2019 and 10th February 2020 with respect to Declan Connolly, Dundrumman, Scotstown, Co Monaghan and wish to advise as follows:

1. Planning permission 18/4 relates to the construction of 2 no. poultry units together with underground washings tanks, vertical meal bins, use existing agricultural entrance and all ancillary site works within existing farmyard complex. The application was approved by the Planning Authority on the 29th August 2018.
2. An Environmental Impact Assessment Report (E.I.A.R) was submitted with the planning application.
3. As per the submitted documentation, existing bird numbers on the farm complex are detailed as 84,000. The proposed development, as per the submitted documentation would increase bird numbers on the complex by a further 100,000 birds.
