**Section 87(1E)(a) of the EPA Act 1992 as amended in respect of a licence
application from Cecil and Lily Clarke for an installation located at
Corraghbrack, County Monaghan, Monaghan**

I refer to correspondence dated 16th December 2020 and 18th February 2021 with respect to Cecil and Lily Clarke, Corraghbrack Co Monaghan and wish to advise as follows:

1. Planning permission 20/200 relates to the construction of 2 no. broiler poultry units together with all ancillary structures including vertical meal bins & underground washings tank, together with associated ancillary site works. This application was approved by the Planning Authority on the 9th December 2020.
2. An Environmental Impact Assessment Report and an Appropriate Assessment Screening Report were submitted with the planning application.
3. As per the submitted documentation, existing bird numbers on the farm complex are detailed as 32,000.
4. The proposed development, as per the submitted documentation, will increase bird numbers on the site to a total of 100,206 (Proposed house 1: 36,985 broilers and proposed house 2: 31,221 broilers).
