Ref – Lack of Response to EPA Licence P0606-04 by the Requisite Regulatory bodies and Departments

For the attention of Director General Laura Burke

Dear Madam

I write in regards to Licence P0606-04, the application by SSE Generation Ireland Limited, site Great Island Generation Station for an Industrial Emissions Licence part of which is to allow the station to discharge 1000 tonnes of Sodium Hypochlorite into the estuary which potentially could be part of the pollution problem that exists in the estuary. I am shocked and dismayed at the lack of response from the organisations, spec bodies and departments that the EPA informed (list attached) about the Licence application, given the disastrous state of the Waterford estuary as regards pollution, habitat destruction, species endangerment (loss?) that all on the list would know about but staying silent on.

An estuary with European designations, Special Area of Conservation (SAC), NATURA Site and Shellfish Waters Designated for which all these requisite Spec bodies and Departments on the list have a role in the protection of. By not commenting the protectors on the list are polluters and not only polluters but are also showing a blatant disregard for human health. With Ireland having a problem with MILK and MILK products, holding potential health dangers for humans associated with using a small amount of Sodium Hypochlorite in the washing down of milking parlours, miniscule amounts in comparison to 1000 tonnes of Sodium Hypochlorite discharged annually into the estuary. These miniscule amounts of Sodium Hypochlorite used in the MILK process having to stop due to potential health concerns even though the finished products for consumption and export, are far removed from the Sodium Hypochlorite base.

The EPA notification of Licence Application P 0606 -04, sent out on 30/09/20 to theRequisite Regulatory bodies and Departments has been met withmass silence no response. The requisite Spec bodies on the list cannot or will not comment on an EPA Licence when granted see e-mail replies. It would appear that "No Accountability or Responsibility" as referred to in the document submitted to the European Commission would appear to be the track record of these regulatory

bodies and departments entrusted with the care and protection of the water and environment. (See attached document)



Now is their time (the requisite regulatory bodies) to provide input and they have been invited to do so by the EPA but all that can be seen and monitored is "Silence". It is inconceivable that there would be no response from these Spec bodies and Departments whose job it is to protect the environment and who have a legal responsibility under Irish and European law to do so.

Should the High Court and Europe see the lack of response from the requisite bodies on the list at this time as evasion and disguise on account of the disastrous condition of the estuary. Where are the "Letters of Formal Notice" for Ireland, from Europe is it possible – credible that the EU does not know Ireland's true record around Rivers, Estuaries and Coastal Waters especially when there are reviews on Ireland's performance on water and Environment sent to Europe well disguised? Is silence and the run around from the requisite Spec bodies and Departments the way Ireland's system is set up to evade EU legislation? In Ireland EIA- NATURA Impact Statements- Appropriate Assessment screenings are given a lot of credibility when in fact they are worthless pieces of paper, hence the disastrous state of Waterford Estuary.





Dear Mr. Moran,

Thank you for your recent correspondence.

The Department of Agriculture, Food and the Marine considers all applications for aquaculture licences in accordance with the provisions of the 1997 Fisheries (Amendment) Act, the 1933 Foreshore Act and applicable EU legislation. All aquaculture licences contain specific terms and conditions which must be adhered to by the operator of the site.

The Department's Marine Engineering Division carried out an inspection at Woodstown Beach in January 2020, following complaints in relation to litter from oyster harvesting in the area. Following this inspection, this Division wrote to you on 6 February 2020 requesting a clean-up of the site.

Issues associated with water quality generally and the Shellfish Water Directive fall under the remit of the Department of Housing, Local Government and Heritage and any queries therein should be directed by you to that Department.

Following consultation with the relevant Inland Fisheries Ireland (IFI) environmental staff I can confirm that as your query relates to an EPA licensed facility it is not within the remit of IFI to investigate the workings or otherwise of another agency.

IFI does not have any powers in legislation or otherwise to investigate or enforce the conditions of a license issued by the EPA. The licensing of such facilities is solely a matter for the EPA.

Dear Pat,

I have taken your concerns to our Environment teams for their advice.

I received the following information:

"The Environmental Protection Agency undertakes a range of regulatory tasks relating to the licensing, permitting, consenting or certification of activities that could have an impact on the environment or on human health. In this context, the Agency is the competent authority for granting and enforcing industrial and waste licences. The Agency undertakes an annual programme of audits and inspections of Agency licensed facilities.

The Minister for Communications, Climate Action and Environment is constrained by the provisions

of Sections 79(3) and 86(5) of the Environmental Protection Agency Act, 1992, as amended, from becoming involved in any way with the licensing of installations under the EPA Act or in the control of installations so licensed.

Therefore, as your query relates to an Agency licenced facility, it is not appropriate for the Minister or Department to comment or interfere in any way."
