The site of the dredging works spans the Lower Suir Estuary and Barrow Suir Nore Estuary. The current Ecological Status of the Lower Suir Estuary is *Good*. The current Ecological Status of the Barrow Suir Nore Estuary is *Moderate*. Both water bodies are *At Risk* of not meeting Good Status in the next WFD cycle.

In respect of the above application for planning IFI wish to make the following observations:

The dredging works have the potential to impact on fish passage into the Nore, Suir and Barrow Rivers and their associated transitional waters. Together these catchments drain an area of over 9,000km2. Dredging is disruptive of the channel bed, disturbing its physical form and ecology by removing or destroying habitats and the species resident within or on the dredged area.

The freshwater and tidal reaches of the Barrow, Nore and Suir and Waterford Harbour are designated as Special Areas of Conservation or SACs under the EU Habitats Directive. Among the range of qualifying interests are anadromous (migratory) species including Atlantic Salmon, Sea Lamprey, Twaite and Allis Shad. In addition, Smelt, listed in the Irish Red Data Book for Vertebrates, has significant populations in these waters. These waters are also important migratory routes for juvenile and adult European Eels, a critically endangered species.

Notwithstanding the maintenance of existing tonnage of dredged material, the timing of works and the extension of the area in which elevated suspended solids loads are generated increases the probability that fish will be adversely impacted.

IFI note with concern that the closed period for plough dredging does not extend to the site at Cheek Point, which is among those for which an increase in the dredging area is proposed. Plough dredging generates elevated suspended solids levels in the water column. Elevated suspended solids levels impact adversely on fish respiration, lead to abrasions and infection, or result in the deposition of fines onto spawning areas; impede swimming or 'obstruct' passage, and impair dissolved oxygen.



Plough dredging relies on river flow and tidal movements to disperse the plume of material created in the dredging process. This has potential to generate very high SS levels on a continuous basis during the operation. This is occurring at the intersection of all three major catchments entering the estuary.

Migrations of eels occur on the new moon, whereas Salmon migrations tend to coincide with the full moon. Both species' migrations coincide with spring tides when plough dredging occurs at the Cheek Point site. Cheek Point lies at the intersection of all three catchments, and is a critical area for fish migration affecting a sizable portion of the total freshwater area of the country.

IFI therefore request that in the interests of the timing and sensitivity of migratory fish species, that consideration be granted to the extension of the closed period from 1 March to 30 June to this area. Extending the closed period can serve a valuable role in reducing potential adverse impacts to the migrating fish.

IFI also request that consideration be given to the greater use of suction or mechanical dredging relative to plough dredging from which the release of suspended solids is far less controlled.

In the event of any incident with the potential to impact surface waters directly or indirectly, the contractor should notify IFI immediately.
