Thank you for your notification of the above-mentioned application.

While IFI welcomes all proposals to improve wastewater treatment facilities, it also considers that all improvements should be compatible with preserving and improving existing receiving water quality and meeting existing legislative requirements with respect to water quality standards. In this case the relevant water quality standards are prescribed by the Environmental Objectives (Surface Waters) Regulations 2009 and the Shellfish Waters Directive (79/923/EEC)

With respect to proposed pumping stations IFI would ask stations are designed and operated in a manner so that there is no overflow discharge to waters. Upgrades should prioritize the separation of combined networks to negate the need for overflows at either treatment plants or treatment plants.
