Background

This application is for a Dumping at Sea Permit Application from Port of Waterford

Fishery Harbours

There are no impacts expected on Dunmore East Fishery Harbour Centre due to the proposed application. But the Port of Waterford should maintain close communication with Dunmore East FHC Harbour Master (Deirdre Lane) to ensure FHC related traffic is not affected by the operations.

Aquaculture

The application is in the vicinity of licenced Aquaculture Sites. Consideration should be given to maintaining the conditions in the existing dumping at sea permit regarding periods of ploughing and works as described during spring tide periods, as there is no evidence given that these have not been successful.

Sea fishing

Sea fishing may occur in this area, however any impact on sea-fishing is not a matter for this office.

Cumulative Impact

MED is not aware of any other developments, plans or projects that may, in conjunction with this application, have other significant cumulative effects.
