### Attachment C.1 Technical Competence and Site Management

Under the proposal the Gleneden facility at Raffeen will be managed directly by the Atlas Environmental Ireland management team. This management team currently manages and controls the Atlas facility (Portlaoise), Shannon Environmental Services (Shannon) and Envirotech (Cork).

Atlas Environmental Ireland Limited (formerly known as Atlas Oil) is one of Irelands premier hazardous waste management companies and has been involved in the handling and processing of hazardous waste since the mid 1970s. Atlas currently operates licensed hazardous waste management premises in Portlaoise (WML Ref 184-1) and Drumaness (Northern Ireland, under E&HS). These facilities deal largely with waste oils and hydrocarbons, oil filters, batteries, oily wastes, contaminated soil and a number of other smaller waste materials. Atlas are also a specialist oil spill clean up contractor, being involved in most large scale oil clean up operations both inland and coastal. In addition Shannon Environmental Services which was acquired by DCC in 2003 and operates a hazardous waste processing plant in Shannon, Co Clare (Ref 145-1). This plant has a substantial chemical processing capability (Biological & Physico-chemical) which is currently undergoing large scale refurbishment, in addition to solvent bulking & blending, metal recovery from photographic waste, IBC/drum washing & shredding operations.

Envirotech based in Ballycureen, Co Cork are a specialist Environmental and Process Technology Company. In particular Envirotech specialise in the operation and maintenance of wastewater treatment plants (Biological & Physico-chemical) within the pharmaceutical, manufacturing and food sectors. In addition Envirotech provide abatement technologies regarding odour control, remediation projects and air purification.

The management of the Atlas (Portlaoise), SES (Shangon) and Cork facilities all come under a single unitary management structure with the ultimate intention to rebrand into a single entity. Atlas in Northern Ireland operates under a slightly different structure although it shares some senior management personnel.

Details of the site management staffs' duties, responsibilities, experience and qualifications are summarized in Table C.1.
