Fehily Timoney & Company (FTC) has been retained by Eleneden Trading Ltd. to prepare a waste licence review for waste licence Registration 1454 in response to a letter issued by the EPA on 29 September 2004.

Gleneden received on 10 January 2005 written potification from the Agency that it was found to be non-compliant with Article 7(1)(b) of the relevant Waste Management (Licensing) Regulations.

On 22 December 2004, FTC placed a telephone call to Ms. Niamh O'Donoghue at the Agency's Regional Office in Cork to enquire about the progress status of the waste licence review application submitted to the Agency on 16 November 2004. Ms. O'Donoghue informed this office that the site notice was in a non-conspicuous location relative to the main road and would need to be relocated. On that same date, FTC contacted Gleneden to advise them to reposition the site notice. Gleneden immediately moved the site notice to the conspicuous location specified by Ms. O'Donoghue. FTC then notified Ms. O'Donoghue by telephone message on the same date that the site notice had been moved. As further evidence that the site notice had been relocated to the new position, please find enclosed an updated drawing.

FTC would like to reiterate that the original position of the site notice prior to 22 December 2004 was the exact location where it was erected for the original waste licence application.
