Re: Proposed licence review and letter in accordance with Article 12(3)(d) of the Waste Management (Licensing) Regulations

Dear Mr. Parker

I refer to your correspondence to the Agency dated 25 February 2004 in relation to a request regarding a review of waste licence reg. No. 47-1. We note that this request relates to;

- A proposed extension to the facility boundary and also of the lined landfill.
- An amendment of the maximum final contour level specified in the licence of 100mOD to reflect the final contour level in the facility's planning permission (108mOD).
- A proposed composting system for putrescible waste separately collected from industrial and commercial sources.

The Agency is of the view that a ~~full review application is not required~~ in this instance. An application may be made under the revised review procedure (as allowed for under Article 6(e) of the Waste Management (Licensing)(Amendment) Regulations, 2002).


The following is required in order that your review may be processed by the Agency.

ARTICE 5, 6 & 7 COMPLIANCE REQUIREMENTS FOR REVIEW OF WASTE LICENCE (Reg. No. 47-1)

- a) Publish and fix a site notice as specified in Articles 5, 6 and 7 of the Waste Management (Licensing) Regulations, 2000.
- b) Submit a notice to the Agency and the relevant planning authority in accordance with Article 9 of the Waste Management (Licensing) Regulations, 2000.

ARTICE 12 COMPLIANCE REQUIREMENTS FOR REVIEW OF WASTE LICENCE (Reg. No. 47-1)


- a) Information specified in Article 12(1)(a) of the Waste Management (Licensing) Regulations, 2000.
- b) Provide a "Site Plan" which shows the extent of the entire facility outlined in red.
- c) State the interest of the applicant in the land subject to the application. Provide name(s) and address(es) of all occupiers of the land or part of on which the application relates (if different from the applicant named above). Provide name(s) and address(es) of the current owner(s) of the land or part of on which the application relates (if different from the applicant named above). A drawing showing the above details should also be included.
- d) Specify the class or classes of activity concerned, in accordance with the Third and Fourth Schedule of the Waste Management Act and provide a summary description of each of the classes of the activity applied for.
- e) Describe the proposed capacity of your facility, and specify whether any revised rates of waste acceptance, waste disposal and/or waste recovery at the facility are proposed or not.
- f) Confirm whether the waste types to be accepted at the facility for disposal at the landfill are in accordance with Article 53 and 54 of the Waste Management (Amendment) Regulations 2002.
- g) Provide details of the proposed extension to the facility including that of the lined landfill and how this is proposed to relate to the landfill areas specified under the existing licence.
- h) Provide details of design considerations/plans regarding the proposed composting facility, to include *inter alia* the following;
 - Proposed location,
 - Specify the waste types proposed to be accepted,
 - Provide an estimate of the expected and maximum quantity of waste types to be accepted,
 - Type of process to be used,
 - Whether to be carried out indoors or outdoors,
 - Odour/gas/dust abatement.
- i) Provide details of the proposed changes to the final contour levels of the landfill, to include *inter alia* the following;
 - Provide a description of the existing surrounding landscape and the landfill profile as specified under the waste licence
 - Describe the proposed amended profile, the impacts on the environment in relation to this proposed amendment and any additional mitigation measures proposed.
- j) Describe the impacts on the environment in relation to the proposed amendments to include details of any alternatives to odour control, landfill gas management, leachate management and restoration and aftercare at the facility that would result from such changes.
- k) Provide information for the purposes of enabling the Agency to make a determination in relation to the matters specified in Section 40(4) of the Waste Management Act, 1996 (including information that allows the Agency to determine whether the facility complies or will comply with the relevant requirements for the time being specified in the Landfill Directive).

- l) Identify any proposed changes to/new monitoring and sampling points and arrangements for monitoring.
- m) Outline the financial provisions and the changes proposed for the facility having regard to the provisions of the Landfill Directive and the Waste Management (Amendment) Regulations, 2002.
- n) Provide a non-technical summary of the revised application.
- o) State the grounds on which the review is made in accordance with Article 12(3)(a) of the Waste Management (Licensing) Regulations, 2000.
- p) Provide the information to accompany the application as specified in Article 12(4) of the Waste Management (Licensing) Regulations, 2000.
- q) Submit the appropriate fee for the review of your licence in accordance with Article 43 of the Waste Management (Licensing) Regulations, 2000.
- r) Describe how the facility complies with the Regional Waste Management Plan.

Where revised drawings are submitted, provide a list of drawing titles, drawing numbers and revision status, which correlates the revised drawings with the superseded versions. When submitting your review application please supply Article 12 information in the form of an original and five copies.
