re: Notice in accordance with Article 14(2)(b)(ii) of the Waste Management (Licensing) Regulations

Dear Sir/Madam ,

I am to refer to the above referenced application for a waste licence relating to a facility at Oxigen Environmental Ltd, Robinhood Industrial Estate, Robinhood Road, Ballymount, Dublin 22. Having examined the documentation submitted, I am to advise that the Agency is of the view that the documentation does not comply with Article 12 and Article 13 of the Waste Management (Licensing) Regulations.

You are therefore requested, in accordance with Article 14(2)(b)(ii) of the regulations, to take the steps and supply the information detailed below:

ARTICLE 12 COMPLIANCE REQUIREMENTS

A Non-Technical Summary

Provide an updated and revised non-technical summary including the omitted information outlined below as well as any further information supplied in response to this notice.

The following information was omitted from the non-technical summary supplied with the waste licence application:

1. Details to show compliance with Section 40(4)(d) of the Waste Management Acts, 1996 – 2003;
2. Details of the proposed environmental monitoring programme;
3. Details of any proposed arrangements for the off-site treatment or disposal of solid and liquid wastes; and,



4. Details of the proposed measures for the closure, restoration, remediation or aftercare of the facility concerned, after the cessation of the activity in question.

D.1 Infrastructure

Supply the pages of the above mentioned attachment detailing D.1.h: *Waste quarantine areas*, D.1.i: *Waste inspection areas* and D.1.j: *Traffic control* which are missing from the application.

H.10 Discharge to Sewer

Revise Table H.10 *Details of Discharges to Sewer* to include details of estimated volumes to be emitted.

J. Environmental Monitoring

Update Drawing No. J.1 *Environmental Monitoring Locations* to include the proposed location of surface water monitoring point TSW2. Also ensure that the proposed monitoring points for surface water and the foul sewer are labelled correctly on the above mentioned drawing. .

K. Contingency Arrangements

Supply the Emergency Response Procedure which is referred to in the above mentioned attachment but has been omitted from the submitted application.

ARTICLE 13 COMPLIANCE REQUIREMENTS

1. Provide information about the size of the development.
2. Supply an outline of the main alternatives studied by the developer.
3. Provide details on the estimated type and quantity of expected residues and emissions resulting from operation of proposed development affecting vibration.
4. Provide an indication of any difficulties, such as technical difficulties or lack of know-how, encountered by the developer in compiling the required information.
5. Provide an updated EIS non-technical summary of all information supplied, including the information requested above as well as the omitted information detailed below:
 - a) Provide an indication of the main reasons for the developer's choice taking into account the environmental effects.
 - b) Provide details of land-use requirement during construction and the operational phases.

In the case where any drawings already submitted are subject to revision as a result of this request, a revised drawing should be prepared in each case. Where such revised drawings are submitted, provide a list of drawing titles, drawing numbers and revision

status, which correlates the revised drawings with the superseded versions. Informal corrections to drawings are not sufficient.

Please supply the information in the form of a one original plus three copies within **one** month of the date of this notice. In addition submit eleven CD-ROM copies of the requested information to the Agency. The e-file should be saved as a 'pdf' file, read only status.

Please note that the application's register number is **152-3**.
