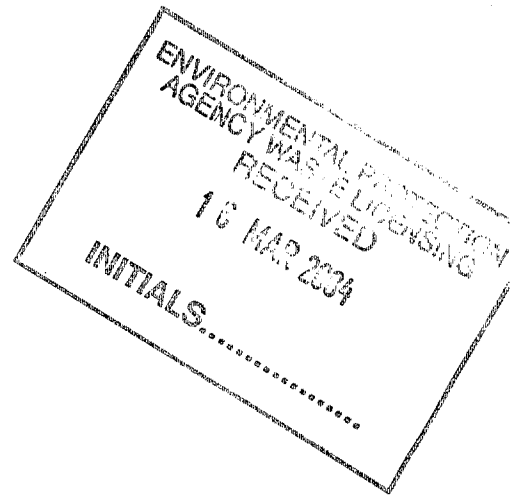

# Management Structure

**(a) The names of all persons who are to provide the management and supervision of the waste activities authorised by the licence;**

- Overall responsibility for management of the Ballaghveny landfill site: Mr. Frank O'Halloran, M.I.E.I., Senior Engineer, Environment Section, North Tipperary County Council.
- Landfill Manager: Ms. Olga Broderick, B.Agri., Env. Sc., Environmental Technician (Acting Grade I) North Tipperary County Council.
- Landfill Deputy Manager: Mr. Brian Quinn BEng (Hons), MIEI, Executive Engineer, Environmental Section, North Tipperary County Council.
- Site caretaker: Mr. Michael Haverty.

**(b) A named contact person for communications with the Sanitary Authority;**

- Mr. Frank O'Halloran, M.I.E.I., Senior Engineer, Environment Section, North Tipperary County Council, is the contact person for communications with the Sanitary Authority.

**(c) Details of the responsibilities for each individual named under (a) above:**

- Mr. Frank O'Halloran, M.I.E.I., Senior Engineer, Environment Section, North Tipperary County Council, has overall responsibility for the landfill site.
- Mr. Brian Quinn, Executive Engineer, is responsible for the day to day implementation of the waste licence for Ballaghveny Landfill. In the absence of the site manager he takes on the responsibilities of the site manager.
- The site manager, Ms. Olga Broderick, is responsible for;
  1. All activities involved in disposal of waste at Ballaghveny landfill site,
  2. Supervision of the workforce and all plant and machinery within the landfill site, and
  3. All environmental monitoring in accordance with the conditions of the licence.
- In the absence of the site manager and Technician, the deputy manager takes on the responsibilities of the site manager.
- The site caretaker is responsible for all bookkeeping, records, and data processing in regard to the weighbridge facility at the landfill site.

# Management Structure

**(d) Details of the relevant experience, competence and qualifications held by each of the persons nominated under (a) above;**

- Mr. Frank O'Halloran, M.I.E.I is a Civil Engineer and a Member of the Institute of Engineers of Ireland and has many years of experience in the supervision and upkeep of Local Authority civil works.
- Mr. Brian Quinn, BEng (Hons), M.I.E.I, hold a degree in Civil Engineering (University of Strathclyde, Glasgow) and has worked for 6 years in Civil Engineer in both the public and the private sector. Main areas covered include landfill construction; constraint report for new town bypass; rural water supply and housing construction.
- Ms. Olga Broderick B.Agri, Env. Sc. holds a degree in Agricultural and Environmental Science (UCD) and has worked in the Environment Section of the local authority for 2 years. She was Deputy Landfill Manager since June 2002.
- Mr. Michael Haverty has been weighbridge operator at Ballaghveny landfill site for 4 ½ years.

**(e) Contingency arrangements for the absences of the named persons from the facility**

In the absence of the named persons from the facility, suitably qualified and experienced staff will be appointed to take up the duties of the aforementioned names.

- In the absence of Mr. Frank O'Halloran, M.I.E.I., Senior Engineer, Environment Section, North Tipperary County Council, a suitably qualified and experienced Senior Executive Engineer will be appointed to take the overall responsibility for management of the Ballaghveny landfill site.
- In the absence of Mr. Brian Quinn, BEng (Hons), M.I.E.I., Executive Engineer, Environmental Section, a suitably qualified and experienced Technician will be appointed to take on the responsibilities of Mr. Brian Quinn.
- In the absence of the site manager, Ms. Olga Broderick, B.Agri., Env. Sc., Environmental Technician Acting Grade I, the Executive Engineer, Mr. Brian Quinn, will take responsibility for all activities involved in disposal of waste at Ballaghveny landfill site. In the absence of both Ms. Olga Broderick and Mr. Brian Quinn, a suitably qualified and experienced environmental technician will be appointed.
- In the absence of the site caretaker, Mr. Michael Haverty, an experienced caretaker will be appointed.
