North Tipperary County Council have a query in relation to the acceptance of treated sludges at Ballaghveny Landfill.

Under the Waste Licence Review North Tipperary County Council applied to amend Condition 5.12.3 of the current Waste Licence which states that " from 1 January 2004, only treated sludges shall be accepted at the facility". NTCC requested that this date be extended to 1 January 2005 to allow for the proposed improvement works at Thurles Sewerage Scheme.

However there have been delays in the contract for the Thurles Works due to gueries from the DEHLG regarding the selection of a contractor. The most likely start date for the works is now January 2005 and the completion date will be the end of September 2005.

At a recent EPA audit at the landfill the client was advised to inform the EPA of this delay under the Review Process.

Please can you inform me as to the status of the Waste Licence Review for Ballaghveny Landfill and this query above.






