



Re: Ballaghveny Landfill WL78-1 – Request for a Review

I refer to your letter of 3 October 2003 in relation to your request for a review of Waste Licence 78-1. We note that this request relates to:

An increase in post-settlement (completion) height of Cells 3-5, from the currently approved 114mOD, to 120mOD (involving a temporary pre-settlement operational height of 121mOD).

The Agency is of the view that a full review application ~~is not required~~ in this instance. An application may be made under the revised Review procedures (as allowed for under Article 12(3)(d) of the Waste Management (Licensing) Regulations 2000 (as amended)).

The following is required in order that your review application may be processed by the Agency:

- (i) Information as specified in, and to support compliance with, Articles 5, 6 & 7 of said Regulations.
- (ii) Such information as may be necessary (having regard to the limited grounds for the review) under Article 12(1). Specifically:-
 - o Sub-articles (a), (d) (f), (g) & (l)
 - o Any implications for existing infrastructure, plant, processes and operations in relation to the proposal (Sub-article (i))
 - o Information on any anticipated changes in emissions as described in Sub-article (k)
 - o Appropriate information to support Sub-article (j)
 - o Sub-article (q) - In particular you are to provide a comprehensive visual impact assessment in relation to the proposal, to be completed and certified by an appropriately qualified and experienced landscape architect/planner. This report is to be accompanied by drawings, sections and photographs, etc., as necessary. You are also required to provide information in relation to any hydrological impact of the proposed changes.
- (iii) Information to support Article 12(3)(a)

- (iv) Information as specified in, and to support compliance with, Article 12(4) (including the appropriate fee).
- (v) Information necessary to support facility classification as detailed in Article 52.
- (vi) Confirm whether the waste types to be accepted are in accordance with Articles 53 & 54
- (vii) Information necessary to support assessment under Article 55 (specifically the statement referred to in Sub-article 55(3)).
- (viii) As provided for in Article 12(1)(r) please include a non-technical summary of the proposal and supporting application information.
