Dear Ms Burke,

I am to refer to the above referenced application for a waste licence relating to a facility at Indaver Ireland, Waste Management Facility, Carranstown, Duleek, Co Meath. Having examined the documentation submitted, I am to advise that the Agency is of the view that the documentation does not comply with Article 12 and Article 13 of the Waste Management (Licensing) Regulations.

You are therefore requested, in accordance with Article 14(2)(b)(ii) of the regulations, to take the steps and supply the information detailed below:

ARTICLE 12 COMPLIANCE REQUIREMENTS

B2 Planning Authority

- 1. An amended Article 9 Notification should be forwarded to the Planning Authority.
- 2. A copy of this amended Notification should be forwarded to the Agency.

B5 Type of Activity

1. Your application should include Activity 8 of the Third Schedule of the Waste Management Act i.e.

Incineration on land or at sea.

2. Activity 8 should be identified as the principal activity (rather than Activity 9 of the Fourth Schedule *i.e.* Use of any waste principally as a fuel or other means to generate electricity).



3. As solidification of incineration residues is proposed, your application should include Activity 7 of the Third Schedule of the Waste Management Act i.e.

Physico-chemical treatment not referred to elsewhere in this Schedule (including evaporation, drying and calcination) which results in final compounds or mixtures which are disposed of by means of any activity referred to in paragraphs 1. to 10. of this Schedule (including evaporation, drying and calcination).

ARTICLE 13 COMPLIANCE REQUIREMENTS

Air Dispersion Modelling

1. It is noted that the air dispersion modelling submitted as part of your waste licence application is more recent than that used in your EIS. Please submit this revised air dispersion modelling to update your EIS.

Your reply to this notice should include a revised non-technical summary (Application and EIS) which reflects the information you supply in compliance with the notice, insofar as that information impinges on the non-technical summary.

In the case where any drawings already submitted are subject to revision consequent on this request, a revised drawing should be prepared in each case. It is not sufficient to annotate the original drawing with a textual correction. Where such revised drawings are submitted, provide a list of drawing titles, drawing numbers and revision status, which correlates the revised drawings with the superseded versions.

The requested information should be submitted to the Agency within one month of the date of this notice, in order to allow the Agency to process and determine your application.

Please supply Article 12 information in the form of an original and five copies and Article 13 information in the form of an original and fifteen copies.
