The Directors resumed consideration of a recommendation from the Office of Licensing and Guidance that the Agency approve the recommended decision. The Directors had deferred a decision on this matter, pending clarification of issues raised during detailed discussions at their meeting on 5 October 2004. The following documentation was again submitted: proposed decision; 127 submissions; summary report of the inspector and report from the Programme Manager, OLG. A copy of the licence application was tabled.

The Directors noted that the Office of Licensing and Guidance had had regard to all relevant waste management plans, in accordance with Section 40 of the Waste Management Act, when recommending the decision.

P Larkin, Director of the Office of Licensing and Guidance, gave a presentation clarifying issues raised by the Directors.

Inspector's Report and Programme Manager's Report

The Directors noted the Inspectors Report and the report of the Programme Manager, OLG, but did not agree with the recommendation on *Waste Types and Quantities*. They decided to allow the waste types applied for, having regard to the total tonnage.
