**Introduction:**

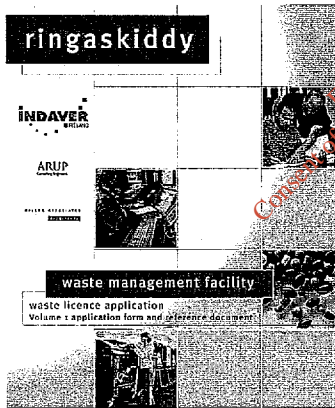

The licence application consists of four volumes namely:

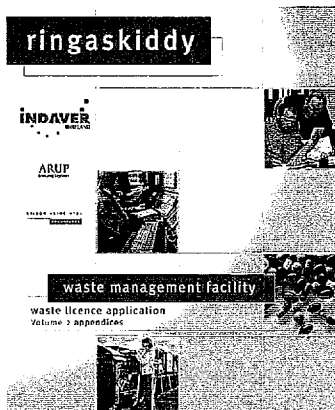
- Waste Licence Application Volume 1 – Application Form & Reference Document

A summary of the planning drawings (in A2 size) has also been included with the application.

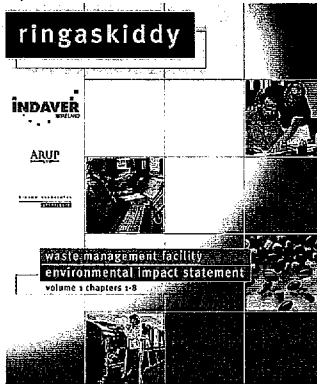
A description of each of the above is supplied below:



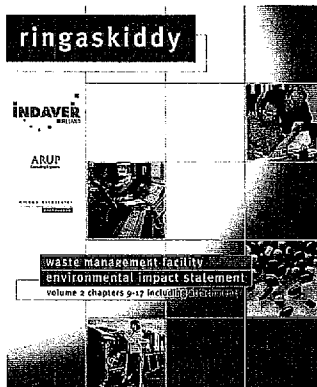
**Waste Licence Application Form & Reference Document:** This volume consists of the completed application form supplying information such as company details, the type of recovery/ disposal activities that are proposed and the Reference Document which includes supporting information for the application.



**Waste Licence Application - Appendices to Reference Document:** This volume contains specific items required in the application such as drawings, copies of newspaper/site notices, financial and insurance details. It also contains copies of specific studies referred to in the Environmental Impact Statement such as the Soil and Hydrogeological Investigation of the Ringaskiddy Site.

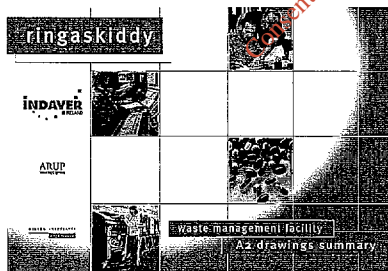


**Environmental Impact Statement Volumes 1 & 2:** These volumes assess the impact that the proposed waste management facility may have on the environment. Topics such as air quality, water, noise and traffic are just some of the areas assessed. For each topic an examination of the existing environment is made, this is then compared to the impact the facility may have during the construction phase and finally the operation phase.
