I am to refer to the above referenced application for a waste licence relating to a facility at Roadstone Dublin Remediation Landfill, Dillonsdown, Deerpark, Newpaddocks and Santryhill Townlands, Blessington, Co Wicklow.

You are requested, in accordance with Article 14(2)(b)(ii) of the regulations, to take the steps and supply the information detailed below:

ARTICLE 12 & 13 COMPLIANCE REQUIREMENTS

- (i) Specify the correct tonnages (T) for the application. Currently there are three estimates:
 - a. 126,200T is the estimate in Attachment H1 of Application;
 - b. 52,000T is the estimate in Appendix 6 of Application (Quantitative Risk Assessment); and,
 - c. a sum of 300,000T is specified in both the site and public notices.
