Re: Notice in accordance with Article 14(2)(b)(ii) of the Waste Management (Licensing) Regulations

Dear Mr Quinlivan,

I am to refer to the above referenced application for a waste licence relating to a facility at Joe McLoughlin Waste Disposal, Ardcolum, Drumshanbo, Co. Leitrim. Having examined the documentation submitted, I am to advise that the Agency is of the view that the documentation does not comply with Article 12 of the Waste Management (Licensing) Regulations.

You are therefore requested, in accordance with Article 14(2)(b)(ii) of the regulations, to take the steps and supply the information detailed below:

## **ARTICLE 12 COMPLIANCE REQUIREMENTS**

- 1. Submit a revised version of Table B.6 identifying one principle activity and amend Attachment B.6 accordingly.
- 2. Submit a revised site plan illustrating the gas storage area, fuel tank/storage, power washer building, diesel generator and the disused office building.
- 3. Attachment D.1.g indicates that there are no fuel storage areas within the licensable area. A recent site visit found a gas storage and oil storage area. Submit details of all fuel storage including details of bunding.
- 4. Clarify and give details of the proposed versus actual activities and plant, on site.

- 5. Submit a technical drawing of the sewerage and surface water drainage infrastructure on site including percolation areas. Give details of the area of the roof and other impervious areas drained for each collection system.
- 6. Provide details of the quarantine area
- 7. Give details of waste disposal arrangements.
- 8. Give details of the proposed hours of operation.
- (a) Proposed hours of operation
- (b) Proposed hours of waste acceptance/handling
- (c) Proposed hours for the civic amenity area
- (d) Any other relevant hours of operation expected.
- 9. Indicate the maximum tonnage of waste to be accepted at this site.
- 10. Submit the European Waste Catalogue Codes for the waste handled on site.
- 11. Submit details of all waste materials generated on the site including name, description and nature as well as on-site recovery/disposal aspects. Complete Tables H.1(i) and H1(ii) of the application form (available at <a href="www.epa.ie">www.epa.ie</a>). Evaluate the waste material for possible reuse, recovery or recycling and submit the results of such evaluations.
- 12. Amend the non- technical summary in accordance with Article 12 of the Waste Management (Licensing) Regulations, 2004.
- 13. Give National Grid References for all monitoring points.
- 14. Provide details of the energy used and outline the measures taken to ensure that energy is used efficiently.

Your reply to this notice should include a revised non-technical summary which reflects the information you supply in compliance with the notice, insofar as that information impinges on the non-technical summary.

In the case where any drawings already submitted are subject to revision consequent on this request, a revised drawing should be prepared in each case. It is not sufficient to annotate the original drawing with a textual correction. Where such revised drawings are submitted, provide a list of drawing titles, drawing numbers and revision status, which correlates the revised drawings with the superseded versions.

Please supply the information in the form of a one original plus three copies within one month of the date of this notice. In addition submit one copy on a CD-ROM to the Agency. The e-file should be saved as a 'pdf' file, read only status.
