The Directors considered a revised recommended decision from the Office of Licensing and Guidance, taking account of the amendments agreed by the Directors at their meeting held on 12 October 2004. The Directors had deferred a decision on this matter pending the submission of the revised document. The following documentation was again tabled: 8 submissions (including additional submission received from Passage West Town Council); summary report of the inspector, copy of the licence application.

P Larkin gave a presentation and indicated some further minor amendments (marked*) made by the Office of Licensing and Guidance for reasons of clarity when revising the recommended decision
