I refer to the above referenced application for a waste licence, which was received by the Agency on 30 March 2005 and to other information in respect of the application received by the Agency on 20 July 2005, 6 September 2005 and 11 October 2005. As the application documentation now complies with the requirements of Article 12) of the Waste Management (Licensing) Regulations as and from 11 October 2005, I am directed to acknowledge the application in accordance with Article 14(2)(a) of the Regulations.

All the application documentation is available for public inspection at the Agency's headquarters during office hours.

I am to advise you that any person may make a submission to the Agency, in writing, in respect of the application, pursuant to Article 15 of the Regulations, which provides as follows:

Extract from the Waste Management (Licensing) Regulations
Submissions to the Agency regarding applications.

15. For the purpose of Section 40(2)(b) of the Acts, a person may make a written submission to the Agency in relation to -

- (i) an application, and
- (ii) such plans, documents and other information and particulars, including an environmental impact statement, as are submitted by the applicant in accordance with articles 12, 13, 14 and 16,

and the Agency shall not give notice of a proposed decision under section 42(2) of the Acts before the expiry of a period of one month following the date of a relevant -

- (a) acknowledgement in accordance with Article 14(2)(a), or
- (b) notice in accordance with Article 16(2)(a), or
- (c) acknowledgement in accordance with Article 16(4),

whichever such date is the later.

The Agency will have regard to any submission made in accordance with the Regulations and will write, in due course, to each person who makes such a submission, to advise them of the Agency's proposed decision on the application.

Any person may make such a submission, in writing, to the Agency, during office hours, to the *Licensing Unit, Office of Licensing & Guidance, Administration, Environmental Protection Agency, Headquarters, P.O. Box 3000, Johnstown Castle Estate, County Wexford.*
