Dear Mr. McNamara,

I am to refer to the above referenced application for a waste licence relating to a facility at Gleneden Trading Ltd, Unit 9, Raffeen Industrial Estate, Raffeen, Monkstown, Cork. You are therefore requested, in accordance with Article 14(2)(b)(ii) of the regulations, to take the steps and supply the information detailed below:

As notified to you the Agency has decided that the transfer of ownership of the facility can be better dealt with as part of the review process of licence number 145-2. In order to process the change of ownership further please complete the following:

- 1. Submit documented evidence of the ownership of the facility at Unit 9, Raffeen Industrial Estate, Raffeen, Monkstown, Co. Cork. If ownership has changed since the submission of the review application details in November 2004 please complete the following:
 - Submit an amended Section B of the licence review application form.
 - Submit an amended review application form to respond to Section 40(7) of the Waste Management Act 1996 to 2003.
 - Issue a newspaper notice and site notice showing the change of ownership, a copy of both should accompany your response to this letter.

In addition supply information on the following

 Confirm characteristics of the emission and limit values requested for the new healthcare waste treatment system. Outline emission levels expected for microorganisms and odour and any monitoring proposed.





Your reply to this notice should include a revised non-technical summary, which reflects the information you supply in compliance with the notice, insofar as that information impinges on the non-technical summary.

In the case where any drawings already submitted are subject to revision consequent on this request, a revised drawing should be prepared in each case. It is not sufficient to annotate the original drawing with a textual correction. Where such revised drawings are submitted, provide a list of drawing titles, drawing numbers and revision status, which correlates the revised drawings with the superseded versions.

Please supply the information in the form of a one original plus three copies within **one** month of the date of this notice. In addition submit one CD-ROM copies of the requested information to the Agency. The e-file should be saved as a 'pdf' file, read only status,
