

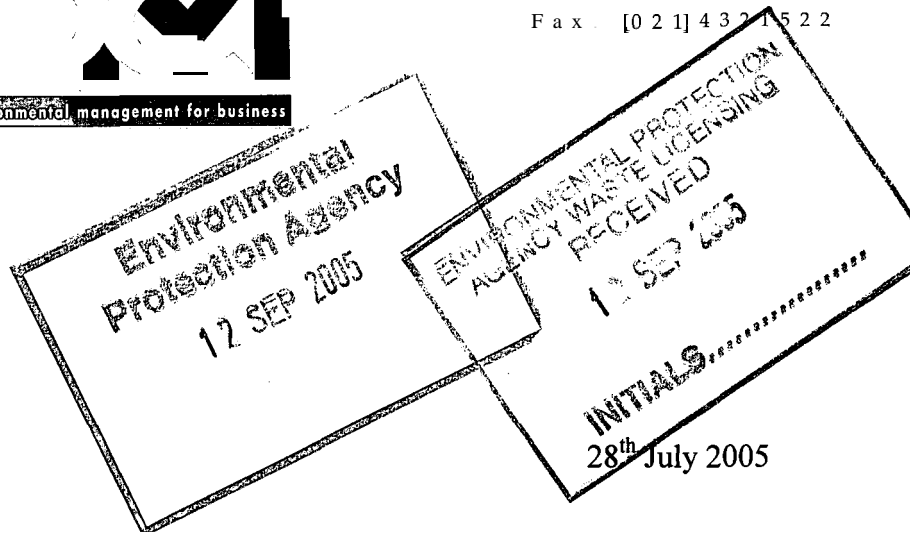

RE: Application to Review Waste Licence Reg. No. 53-2 – Accompanying Article 14 Response

Dear Ms. Hermansen,

I refer to the application by Greenstar Ltd to review the Waste Licence for its Fassaroe Depot Materials Recovery and Transfer Facility, the purpose of which is to amend certain conditions of the existing licence. In addition to those conditions referenced in the review application, which was submitted to the Agency in September 2004, Greenstar Ltd wishes to amend the following: -

- Condition 1.4 and Schedule A to allow the acceptance of the following waste types: refrigerators, electrical equipment and construction waste containing asbestos. The relevant EWC codes and anticipated quantities are presented in the Table below.

EWC Code	Description	Amount (Tonnes /year)
20-01-23*	Discarded equipment containing chlorofluorocarbons	200
20-01-35*	Discarded electrical and electronic equipment other than those mentioned in 20-01-21 and 20-01-23 containing hazardous components	200
17-06-05*	Construction materials containing asbestos	2,000

The grounds for seeking the review of Conditions 1.4 and Schedule A are to allow individual householders and small commercial activities to deliver electrical and electronic waste (e.g. refrigerators and visual display units containing activated glass and cathode ray tubes) and bonded asbestos waste materials (e.g. roof sheeting, cladding and gutters) to the civic amenity area. The wastes will be transferred from the site to appropriate off-site recovery/disposal facilities.




- Condition 4.8, to allow for a further three years to complete the restoration of the site (until April 2009). The grounds for seeking the review are that the Bord Gais gas pipeline which runs through the site has delayed the implementation of the restoration plan.

Greenstar have been in negotiations with Bord Gais for some considerable time in relation to the works that must be carried out over and adjacent to the pipeline as part of the overall restoration plan for the site.

Greenstar recently received agreement from Bord Gais regarding the proposed method for protecting the pipeline which will allow the restoration process to commence in this area. The delay in obtaining Bord Gais approval to fill over the main and restore the site has delayed the site restoration programme and the development of the Phase II of the waste transfer building. A copy of the letter from Bord Gais is included with this letter. Following receipt of the Bord Gais written agreement, Greenstar engaged EG Pettit & Co. to undertake a detailed design of a concrete apron to protect the gas main and then obtained Bord Gais's approval prior to tendering. Construction of the concrete apron will commence in August 2005.
