re: Notice in accordance with Article 8 of the Waste Management (Licensing)
Regulations

Dear Sir/Madam

I am to refer to the above referenced application for a waste licence relating to a facility at Clonbulloge Ash Repository, Cloncreen Bog, Clonbulloge, Co. Offaly. I am directed to advise you that it appears to the Agency that the notices published and erected or fixed in relation to the application do not comply with Article 6 and 7 of the Waste Management (Licensing) Regulations 2004 (S.I. 395/2004).

- 1. The notices do not specify that the activity applied for is <u>Class 1</u> of the Third Schedule of the Waste Management Acts, 1996-2005. In addition the wording detailed for the activity is incorrect. The notices should contain wording from Sections 54 and 55 of the POE Act, 2003.
- 2. The notices do not specify the quantity and nature of wastes involved in accordance with Article 6(c) of the Waste Management (Licensing) Regulations.
- 3. The notices do not state that an Environmental Impact Statement will be submitted to the Agency in accordance with Article 6(d) of the Waste Management (Licensing) Regulations.
- 4. The notices do not reflect the wording of Article 6(e)(ii) of the Waste Management (Licensing) Regulations.

The Agency therefore requires you, in accordance with Article 8 of the regulations, to

1. Publish an amended newspaper notice in accordance with Article 6 of the Waste Management (Licensing) Regulations. The notice should be published in the two newspapers which carried the original notice.

- 2. Replace the existing site notice with an amended notice that complies with Article 7 of the Waste Management (Licensing) Regulations.
- 3. Maintain the notice as amended at a location complying with Article 7 of the Waste Management (Licensing) Regulations for a period of two months following the making of the specified amendment.
- 4. An amended written notice should be given to the relevant planning authority in accordance with Article 9 of the Waste Management (Licensing) Regulations including the specified amendments.
- 5. The above requirements should be carried out within **two weeks** of the date of this notice.

The Agency further requires you to submit the following evidence in relation to compliance with the above requirement:

- 1. An original of the newspapers and two copies of the relevant page of the newspapers in which the amended notice have been published.
- 2. An original and two copies of both a letter stating the date on which the amended site notice was fixed and a drawing showing its location on site.
- 3. An original and two copies of the text of the amended notice erected or fixed in accordance with Article 7.
- 4. An original and two copies of the amended written notice to the relevant planning authority in accordance with Article 9.

The evidence requested should be submitted within <u>two weeks</u> of the date of this notice, in the form of a one original plus two copies. In addition submit two copies of the requested information in electronic searchable PDF format on a CD-ROM to the Agency.

Please note that the format of the application's register number has been revised to 49-2.
