The Directors considered the following documentation: proposed decision issued on 12 July 2005; objection from the Applicant; report and recommendations of the Technical Committee, Office of Licensing and Guidance. A copy of the licence application was tabled.

Technical Committee Report

The Directors considered the Technical Committee Report and noted that, having considered all the issues raised in the Applicant's objection to the proposed decision by the Agency to refuse to grant a licence for an engineered landfill on-site, and taking account of a report from the Geological Survey of Ireland, the Committee recommended that the EPA issue a Waste Licence to the Applicant requiring all wastes on the site to be excavated for processing and requiring all non-inert waste to be despatched off-site to an approved disposal/recovery facility.

Following discussion, the Directors accepted the recommendation to grant a licence, as detailed in the Technical Committee's Report dated 30 January 2006. They confirmed their earlier decision to refuse permission to the Applicant to construct an engineered landfill for the disposal of waste at the site in Blessington, Co Wicklow.

The Directors considered the Recommended Final Decision, as follows:

Following discussion, it was confirmed that the licensed activities are restricted to the remediation and removal of the historical waste and specifically prohibits the importation of waste to the site.

The Directors decided to grant a licence to Roadstone Dublin Limited, Blessington, Co Wicklow, Register of Licence No 213-01, in respect of their facility at Dillonsdown, Deerpark, Newpaddocks and Santryhill Townlands, Blessington, Co Wicklow, subject to the conditions as set out in the licence document.
