APPLICATION TO THE ENVIRONMENTAL PROTECTION AGENCY

FOR A WASTE LICENCE

Notice is hereby given in accordance with the provisions of the Waste Management Act, 1996, that Lawlor Brothers Waste Disposal Limited trading as Access Skips is applying to the Environmental Protection Agency for a Waste Licence for the company's waste Recycling Centre at JFK Industrial Estate, John F Kennedy Road, Naas Road, Dublin 12 (National Grid Reference E 309600, N232000).

The principal activity carried out at the site, as specified in the Fourth Schedule to the Waste Management Act, 1996, is as follows:

"2. Recycling or reclamation of organic substances which are not used as solvents (including composting and other biological transformation processes.)"

Other activities carried out at the site, as specified in the Fourth Schedule to the Waste Management Act, 1996, are as follows:

- "3. Recycling or reclamation of metals and metal compounds."
- "4. Recycling or reclamation of other inorganic materials."
- "13. Storage of waste intended for submission to any activity referred to in a preceding paragraph of this schedule, other than temporary storage, pending collection, on the premises where such waste is produced."

The activities carried out at the site sas specified in the Third Schedule to the Waste Management Act, 1996, are as follows:-

- " 11. Blending or mixture prior to submission to any activity referred to in a preceding paragraph of this Schedule."
- " 12. Repackaging prior to submission to any activity referred to in a preceding paragraph of this Schedule."
- "13. Storage prior to submission to any activity referred to in a preceding paragraph of this Schedule, other than temporary storage, pending collection, on the premises where the waste concerned is produced."

It is proposed that the Recycling Centre will process up to 95,000 tonnes per year of non-hazardous commercial, industrial, household, construction and demolition wastes.

A copy of the Waste Licence Application, Environmental Impact Statement and such further information relating to the application as may be furnished to the Agency in the course of the Agency's consideration of the application will, as soon as practicable after receipt by the Agency, be available for inspection or purchase at the headquarters of the Agency, PO Box 3000, Johnstown Castle Estate, County Wexford, Ireland.
