re: Notice in accordance with Article 14(2)(b)(ii) of the Waste Management (Licensing) Regulations

Dear Ms Griffin

I am to refer to the above referenced application for a waste licence relating to a facility at Listowel Civic Amenity Centre, Tanavalla Industrial Estate, Garryantanvally, Tralee Road, Listowel. Having examined the documentation submitted, I am to advise that the Agency is of the view that the documentation does not comply with Article 12 of the Waste Management (Licensing) Regulations.

You are therefore requested, in accordance with Article 14(2)(b)(ii) of the regulations, to take the steps and supply the information detailed below:

ARTICLE 12 COMPLIANCE REQUIREMENTS

A Location of the Activity

1. Confirm the National Grid Reference of the facility. Clarify the reference with regard to the information published in the site and newspaper notices.

B. Infastructure & Operation

- 1. Clarify in relation to Drawings 10599-0001 and 10599-2001 the location for the hazardous goods and bring bank areas.
- 2. Provide detailed specifications on the structure/s and storage areas provided for the storage of all household hazardous waste types proposed including bunding.
- 3. Describe the unit operation for the acceptance of household hazardous waste on site. Provide a detailed flow diagram of the whole process along with a brief



description detailing its management and maintenance plans. This should include details on how hazardous waste from one category will be separated from hazardous waste from another so as to prevent accidental mixing.

C. Emissions

1. Complete tables E.2 (i) and E.2 (ii) of the application form.

D. Control & Monitoring

1. Provide a labelled map of the facility indicating the location of all proposed monitoring locations for all environmental media. Complete tables F.2 to F.6 where relevant.

Your reply to this notice should include a revised non-technical summary, which reflects the information you supply in compliance with the notice, insofar as that information impinges on the non-technical summary.

In the case where any drawings already submitted are subject to revision consequent on this request, a revised drawing should be prepared in each case. It is not sufficient to annotate the original drawing with a textual correction. Where such revised drawings are submitted, provide a list of drawing titles, drawing numbers and revision status, which correlates the revised drawings with the superseded versions.

Please supply the information in the form of a one original plus two copies within **one** month of the date of this notice. In addition please submit two copies of the requested information in electronic searchable PDF format on a CD-ROM to the Agency. Please note that all maps/drawings should not exceed A3 in size.
