Dear Mr. Goff,

Further to your correspondence requesting permission to increase your rate of disposal of waste at Corranure Landfill Site to 5,000 tonnes per annum, please be advised that current position with regard to same is as follows:

- Cell No. 2 at Corranure Landfill is currently under construction; therefore, we are currently operating at limited capacity.
- We are awaiting decision in regard to an application for a Review of Waste Licence for Corranure Landfill which includes for an increased intake limit for facility.

In light of the above situation we are at present unable to offer your company access to site for an increased rate of waste disposal of 5,000 tonnes per annum. However, we envisage that both of the above situations will be satisfactorily resolved in the near future at which point we will revisit your request.

We will of course continue to grant you access to site at current disposal rates.
