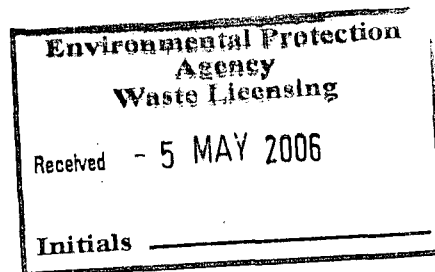

Regulations, 2004 (SI No. 395
of 2004) in respect of its Waste
Transfer Station at the
aforementioned address. The
National Grid Reference for the
activity is 2583E, 1095N.

Fourth Schedules of the Waste
Management Acts 1996 to 2003
and as amended are:

Principal Activity:
Third Schedule, Class 12.
Repackaging prior to submis-
sion to any activity referred
to in a preceding paragraph of
this Schedule.

Class 11. Blending or mixture
prior to submission to any
activity referred to in a
preceding paragraph of this
Schedule.

Class 13. Storage prior to sub-
mission to any activity referred
to in a preceding paragraph of
this schedule, other than tem-
porary storage, pending collec-
tion, on the premises where the
waste concerned is produced.

2. Fourth Schedule

reclamation of organic sub-

and other biological transforma-
tion processes) which are not
used as solvents.

Class 3: Recycling or reclama-
tion of metals and metal com-
pounds.

Class 4. Recycling or reclama-
tion of other inorganic materials.
Class 13. Storage of waste
intended for submission to an
activity referred to in a preced-
ing paragraph of this Schedule,
other than temporary storage,
pending collection, on the prem-
ises where such waste is pro-
duced.

The review is made for the dis-
posal of waste (other than haz-
ardous waste) at a facility (other
than a landfill facility) where the
annual intake is likely to exceed
25,000 tonnes but be less than
100,000 tonnes.

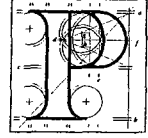

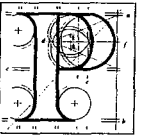
