**TRANSFER OF A WASTE LICENCE**

Decision of the Agency, under Section 47(5) of the Waste Management Acts,  
1996 to 2005

*Waste Licence Register No:* **W0058-01**

The Agency, in exercise of the powers conferred on it by the Waste Management Acts, 1996 to 2005, for the reasons hereinafter set out, hereby transfers waste licence register number W0058-01 from Waste Disposal (Sligo) Ltd., Deepwater Quay, Sligo, to Greenstar Limited. Waste Licence Register No W0058-01 licenses the carrying on of the waste activities set out below at Deepwater Quay, Sligo, subject to twelve Conditions, as set out in the waste licence.

*Licensed Waste Disposal Activities in accordance with the Third Schedule to the  
Waste Management Acts, 1996 to 2005*

<b>Class 11.</b>	<b>Blending or mixture prior to submission to any activity referred to in a preceding paragraph of this Schedule.</b> This activity is limited to bulking and transfer of waste
<b>Class 13.</b>	<b>Storage prior to submission to any activity referred to in a preceding paragraph of this Schedule, other than temporary storage, pending collection, on the premises where the waste concerned is produced.</b> This activity is limited to storage prior to bulking and transfer of waste

*Licensed Waste Disposal Activities in accordance with the Fourth Schedule to the Waste Management Acts, 1996 to 2005*

<b>Class 2.</b>	<b>Recycling or reclamation of organic substances which are not used as solvents (including composting and other biological transformation processes).</b> This activity is limited to recovery of paper, wood, plastic and organic waste
<b>Class 3.</b>	<b>Recycling or reclamation of metals and metal compounds.</b> This activity is limited to the recovery of metals
<b>Class 4.</b>	<b>Recycling or reclamation of other inorganic materials.</b> This activity is limited to recovery of glass and construction and demolition waste
<b>Class 13.</b>	<b>Storage of waste intended for submission to any activity referred to in a preceding paragraph of this Schedule, other than temporary storage, pending collection, on the premises where such waste is produced.</b> This activity is limited to the storage of waste prior to recovery.

In accordance with Section 47(6) of the Acts, Greenstar Limited is deemed to have assumed and accepted all liabilities, requirements and obligations provided for in or arising under the licence, regardless of how and in respect of what period, including a period prior to the transfer of the licence, they may arise.

### **REASONS FOR THE DECISION**

Pursuant to Section 47(5)(a) of the Acts, the Agency is satisfied, on the basis of the information available, that Greenstar Limited is entitled to be regarded as a fit and proper person to be granted a like waste licence. Pursuant to Section 47(5)(b) of the Acts, the Agency is satisfied, on the basis of the information available, that Greenstar Limited has made adequate financial provision to discharge the financial commitments or liabilities that will be entered into or incurred in carrying on each of the activities to which the licence relates, or in consequence of ceasing to carry on any of those activities. In reaching this decision the Agency has considered the application and supporting documentation received from the joint applicants and the report of its inspector.
