Notice in accordance with Article 8 of the Waste Management (Licensing)
Regulations 2004

## Dear Mr McCarthy

I am to refer to the above referenced application for a waste licence review relating to a facility at Tramore Waste Disposal Site, Tramore Intake & Tramore Burrows, Tramore, Co. Waterford. I am directed to advise you that it appears to the Agency that the Site Notice erected and Newspaper Notice published in relation to the application are misleading or inadequate in the following respects:

- (i) The classes of activity under the Third and Fourth Schedules of the Waste Management Acts 1996 to 2005 identified on the Site Notice and in the Newspaper Notice do not reflect all classes of activity concerning the entire facility (closed landfill, civic waste facility, proposed composting facility).
- (ii) The location of the Site Notice, as shown on Drawing LRA-01 (submitted 8<sup>th</sup> December 2004) does not satisfy the requirements of Article 7 of the Regulations, insofar as it is not erected in a conspicuous position on or near the main entrance to the facility from a public road, or on any other part of the facility adjoining a public road. Furthermore, the Site Notice shall be of A3 size or larger, so that the notice shall be capable of being read by persons using the public road.

The Agency requires you to submit the following evidence in relation to compliance with the above requirements:

- (i) Erect a Site Notice with the necessary amendments in a location in accordance with Article 7(1)(b) of the Regulations, and submit evidence of same to the Agency;
- (ii) Republish the Newspaper Notice with the necessary adjustments, and submit evidence of same to the Agency.





The evidence requested should be submitted within <u>one month</u> of the date of this notice, in the form of a one original plus two copies. In addition submit two copies of the requested information in electronic searchable PDF format on a CD-ROM to the Agency. Please note that all drawings/maps should not exceed A3 in size.

Please note that the format of the application's register number has been revised to W0075-02.
