re: **Waste Licence Review Application W0075-02 in respect of a facility at Tramore Waste Disposal Site, Tramore Intake & Burrows, Tramore, Co. Waterford.**

Notice in accordance with Article 14(2)(b)(ii) of the Waste Management (Licensing) Regulations 2004

Dear Mr McCarthy,

I am to refer to the above referenced application for a waste licence review relating to a facility at Tramore Waste Disposal Site, Tramore Intake & Tramore Burrows, Tramore, Co. Waterford. Having examined the documentation submitted on 24th March 2006, I am to advise that the Agency is of the view that the documentation does not comply with Article 12 of the Waste Management (Licensing) Regulations.

You are therefore requested, in accordance with Article 14(2)(b)(ii) of the regulations, to take the steps and supply the information detailed below:

ARTICLE 12 COMPLIANCE REQUIREMENTS

1. As required by Article 12(1)(f), specify all classes of activity concerning the entire facility (closed landfill, civic waste facility and proposed composting facility) in accordance with the Third and Fourth Schedule of the Waste Management Acts, 1996 to 2005. Provide a summary description of each class applied for. Indicate whether the classes authorised under Licence Reg. No. 75-1 are still applicable, and identify any classes to be removed, as appropriate. Note that the recovery of landfill gas by flaring/electricity generation is a waste recovery activity covered under Class 9 of the Fourth Schedule.
2. As required by Article 12(1)(g), specify in tabular form, by reference to the relevant European Waste Catalogue Codes, the types and quantities of waste which will be treated, recovered or disposed of at the civic waste facility.
3. Submit a suitably scaled site plan of the entire facility, showing the site boundary outlined in red. In addition, submit a suitably scaled map which shows all monitoring and sampling points identified in Licence Reg. No. 75-1 (landfill gas, noise, surface water, ground water and leachate), any further points agreed with the Agency since grant of Licence Reg. No. 75-1, and the monitoring and sampling points proposed in this licence review application.



4. Provide an update on the current status of final capping works, landfill gas infrastructure and leachate management infrastructure specified under Licence Reg., No. 75-1.
5. Submit the appropriate fee for the review of your waste licence in accordance with Article 41 of the Waste Management (Licensing) Regulations 2004. Note that two fees are required if disposal and recovery are to occur. The Agency notes that you have provided a fee of €5,000. Under the Second Schedule of the Regulations, the relevant fees are as follows:

Waste Activity	Amount of fee for a review of a waste licence
3.3 The disposal of waste (other than hazardous waste) at a facility (other than a landfill facility) where the annual intake is less than 25,000 tonnes.	€6,000
4. The recovery of waste	€6,000
Fee Payable	€12,000 ^{Note 1}


Note1: The applicant may apply for a refund in respect of the fee payable. The Agency shall have absolute discretion to refund up to 50% of the fee payable, as provided under Article 45(1) of the Waste Management (Licensing) Regulations 2004.

The Agency refers you to an Article 8 notice issued today and advises that you assess the implications of the above questions in meeting the requirements of Article 8(iii) of the Regulations.

Your reply to this notice should include a revised non-technical summary which reflects the information you supply in compliance with the notice, insofar as that information impinges on the non-technical summary. Please supply the information in the form of a one original plus two copies within one month of the date of this notice. In addition please submit two copies of the requested information in electronic searchable PDF format on a CD-ROM to the Agency. Please note that all maps/drawings should not exceed A3 in size.
