such plans, documents and other information and particulars, including an environmental impact statement, as are submitted by the applicant in accordance with Articles 12, 13, 14 and 16, and the Agency shall not give notice of a proposed decision under Section 42(2) of the Act before the expiry of a period of one month following the date of a relevant – acknowledgement in accordance with Article 14(2)(a), or

- (b) notice in accordance with Article 16(2)(a), or
- (c) acknowledgement in accordance with Article 16(4), whichever such date is the later.

The application and associated correspondence, including acknowledgements, notifications and general correspondence are available to view on the Agency Website at <u>www.epa.ie/licensing</u> and also on the public file as they arise, that file may be inspected by any person during office hours at the Agency's headquarters.

You are advised to refer to the website/public file for information on the progress of the application. The Agency will write to you to inform you of its proposed decision on the application in due course.
