Dear Seamus

South East Recycling Company Ltd formally withdrew their application for a review of their existing waste licence (W0111-01) on 18th December 2006. The Agency formally acknowledged the withdrawal on 9th January 2007. Consequently the Agency is not in current receipt of a review waste licence application from South East Recycling Company Ltd.

The Office of Environmental Enforcement provides public access to information in relation to the enforcement of Waste and Integrated Pollution Control Licences. This includes all correspondence from the licensee, the EPA and third parties. Access is provided regionally at the Agency's offices in Wexford, Castlebar, Cork and Dublin.

The public files for South East Recycling Co. Ltd. (Waste Licence Reg. No. W0111-01) are available at our Wexford Regional Office. To ensure availability of files at the time of your visit, you should make a prior appointment with the office by telephoning 053-9160600.

The Annual Environmental Report (AER) for South East Recycling Co. Ltd. for 2005 is currently on file. The AER for 2006 is due to be submitted in the coming weeks, and will be placed on our public access files then.

With regard to the amounts of waste accepted on the site, the licensee accepted 30,076 tonnes in 2005, and 36,436 tonnes between 01/01/06 and 21/12/06.

Seventeen (17) complaints have been received by the Agency in relation to this facility in the period between September 2004 and January 2007 (inclusive).
