In accordance with Article 34 of the Waste Management (Licensing) Regulations, the Agency hereby notifies you of its decision to grant a revised waste licence to Advanced Environmental Solutions (Ireland) Ltd., subject to conditions, in respect of a facility at Advanced Environmental Solutions (Ireland) Ltd, Kyletalesha & Kyleclonhobert, Portlaoise, County Laois. This decision was made following consideration of the objection and technical committee report to the Agency's proposed decision in accordance with the Waste Management Acts, 1996 to 2005 and related Regulations.
