Waste Licence Register No W0148-01 licenses the carrying on of the waste activities set out below at Townlands of Carrowmoneash, Oranmore, County Galway, subject to 12 Conditions, as set out in the waste licence.

Pursuant to Section 47(5)(b) of the Acts, the Agency is satisfied, on the basis of the information available, that The City Bin Company Limited has made adequate financial provision to discharge the financial commitments or liabilities that will be entered into or incurred in carrying on each of the activities to which the licence relates, or in consequence of ceasing to carry on any of those activities. In reaching this decision the Agency has considered the application and supporting documentation received from the joint applicants and the report of its inspector.
