Dear Mr Geary,

I am to refer to the above referenced application for a waste licence relating to a facility at **South East Recycling Company Ltd, Carrigbawn, Pembrokestown, Co. Wexford.** Having examined the documentation submitted, I am to advise that the Agency is of the view that the documentation does not comply with Article 12 of the Waste Management (Licensing) Regulations.

You are therefore requested, in accordance with Article 14(2)(b)(ii) of the regulations, to take the steps and supply the information detailed below:

## **ARTICLE 12 COMPLIANCE REQUIREMENTS**

The Agency notes from the application submitted that the financial statements submitted are for Greenstar Holdings Ltd. South East Recycling Company Ltd is a registered limited company and the Agency therefore requires the financial statements specifically for South East Recycling Company Ltd to be submitted.

Your reply to this notice should include a revised non-technical summary, which reflects the information you supply in compliance with the notice, insofar as that information impinges on the non-technical summary.

In the case where any drawings already submitted are subject to revision consequent on this request, a revised drawing should be prepared in each case. It is not sufficient to annotate the original drawing with a textual correction. Where such revised drawings are submitted, provide a list of drawing titles, drawing numbers and revision status, which correlates the revised drawings with the superseded versions.



Please supply the information in the form of a one original plus two copies <u>within seven days</u> from the date of this notice. In addition submit sixteen copies of the requested information to the Agency in electronic searchable PDF format on CD-ROM. Please note that all maps/drawings should not exceed A3 in size.
