For the purpose of Section 40(2)(b) of the Acts, a person may make a written submission to the Agency in relation to -</p> <p>(i) an application, and</p> <p>(ii) such plans, documents and other information and particulars, including an environmental impact statement, as are submitted by the applicant in accordance with articles 12, 13, 14 and 16,</p> <p>and the Agency shall not give notice of a proposed decision under section 42(2) of the Acts before the expiry of a period of one month following the date of a relevant -</p> <p>(a) acknowledgement in accordance with Article 14(2)(a), or</p> <p>(b) notice in accordance with Article 16(2)(a), or</p> <p>(c) acknowledgement in accordance with Article 16(4),</p> <p>whichever such date is the later.</p>

The Agency will have regard to any submission made in accordance with the Regulations and will write, in due course, to each person who makes such a submission, to advise them of the Agency's proposed decision on the application.
