
Mayo County Council has also applied to An Bord Pleanála for approval for the proposed development in accordance with Section 175 of the Planning and Development Act 2000.

An extension of the original licenced boundary will be required in order to accommodate the proposed development (as per the enclosed drawings). Mayo County Council owns the site for the proposed development. The proposed facilities will be developed using the Public Private Partnership (PPP) process, with the Sludge Hub Centre and Leachate Treatment Facility being developed and operated by a private Contractor. The whole facility, including the existing landfill will be covered by a single waste licence, with Mayo County Council being the licence holders.

The development of the Sludge Hub Centre and Leachate Treatment Facility is critical to the infrastructural needs of County Mayo in terms of facilitating existing populations and sustainable growth and it is hoped that Agency will be in a position to make a decision on the application at the earliest opportunity.
