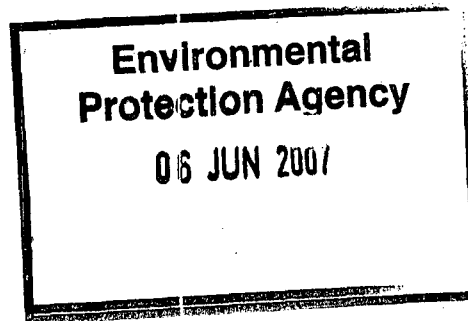

 Waterford Utility Services (Waste Disposal) Ltd is applying to the Environmental Protection Agency for a review of Waste Licence Reg. No. W0116-01 in respect of its waste transfer station operations in the townland of Carriganard, Six Cross Roads, Butlers-town, Co. Waterford which is located at National Grid Reference: E2585 N1091. 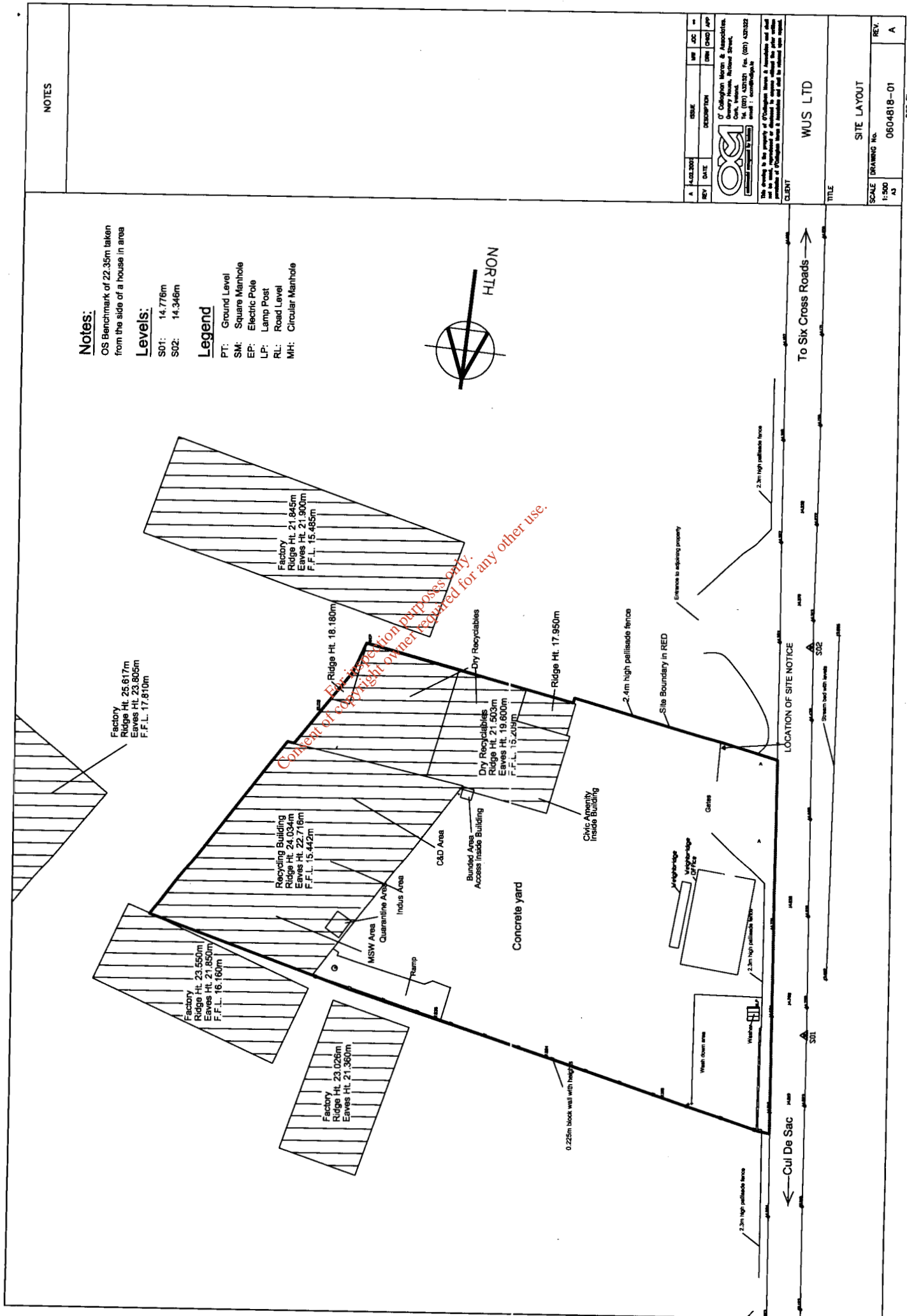
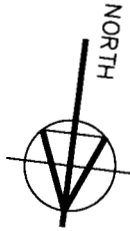
OS Benchmark of 22.35m taken from the side of a house in area


