Further to our letter of 22nd May, 2007 and following receipt on 28th June, 2007 of a revised non technical summary in respect of information submitted to the Agency regarding your environmental Impact Statement (EIS) on 18th May, 2007, I am directed to re-acknowledge the application in accordance with Article 14(2)(a) of the Regulations.

I refer to the above referenced application for a waste licence which was received by the Agency on 5 July 2006 (*and to other information in respect of the application received by the Agency on 19 December 2006, 19 January 2007 and 18 May 2007 and 28th May, 2007*). The application documentation now complies with the requirements of Article 12 and (Article 13(1)) of the Waste Management (Licensing) Regulations as and from 28th June, 2007.

All the application documentation is available for public inspection at the Agency's headquarters during office hours.

I am to advise you that any person may make a submission to the Agency, in writing, in respect of the application, pursuant to Article 15 of the Regulations, which provides as follows:

Extract from the Waste Management (Licensing) Regulations
Submissions to the Agency regarding applications.

15. For the purpose of Section 40(2)(b) of the Acts, a person may make a written submission to the Agency in relation to -

- (i) an application, and
- (ii) such plans, documents and other information and particulars, including an environmental impact statement, as are submitted by the applicant in accordance with articles 12, 13, 14 and 16,

and the Agency shall not give notice of a proposed decision under section 42(2) of the Acts before the expiry of a period of one month following the date of a relevant -


- (a) acknowledgement in accordance with Article 14(2)(a), or
- (b) notice in accordance with Article 16(2)(a), or
- (c) acknowledgement in accordance with Article 16(4),

whichever such date is the later.

The Agency will have regard to any submission made in accordance with the Regulations and will write, in due course, to each person who makes such a submission, to advise them of the Agency's proposed decision on the application.

Any person may make such a submission, in writing, to the Agency, during office hours, to the *Licensing Unit, Office of Climate Change, Licensing & Resource Use, Administration, Environmental Protection Agency, Headquarters, P.O. Box 3000, Johnstown Castle Estate, County Wexford.*
