Please accept the enclosed information as a submission.

The water supply at the Nevitt in the aquifer of Fingal.

The warning signs;

The horticultural industry of Fingal can be traced back 300 years approx. and obviously depends on acess to millions of litres of water per day.

Rouqes map of 1750 showing the Bog of the Ring beside the Nevitt. We now know the reason why; gravel, bedrock sloped, fault line etc.

The map of the year 1836, showing all the risers in the area [ water coming out of the ground ].

The two old walk in artesian wells [3] meter deep approx ] at Whelans and Mourns.

Talk to Jim Burke, the original engineer with Dublin city Council Board of Works [Fingal Council not an entity yet] to work on the Bog of the Ring in 1963. Nevitt Lusk Action Group NLAG asked Jim for a report [previous submission] which basically says this whole aquifer is one huge water resourse, it is all connected. Since then we know why the aquifer is all connected; gravel. Bog of the Ring, Annsbrooke, Corduff, all the wells drilled through out this aquifer, all the old and new gravel quarries and of course the old gravel quarry in the NEVITT.

At this stage, they knew a major North/ South fault line existed from the water supply, through the Nevitt and through Annsbrooke. Obviously, a major pathway for water and leachate.

The first well, that was drilled in Maggie Kavanagh field is artesian. The well water flooded the field, road and later a team had to come out and capped the well. The cap eventually blew off the well [all recorded and Dr. Paul Ashley also saw this well]. Alarm bells should have been ringing at this stage.

When the wells were been drilled in the Nevitt, it was obvious to the drillers that there was lots of gravel, lots of water and very little clay.

Dr. Paul Ashley first report clearly states that the public water supply would be at risk.

GSI report, which clearly shows the zone of contribution zoc extending into the Nevitt and therefore R4.

Alarm bells should have been ringing constantly at this stage.
