Reasons for the Decision

The Environmental Protection Agency (the Agency) is satisfied, on the basis of the information available, that subject to compliance with the conditions of licence Reg. No. W0213-01 granted on the 9th February 2006, and amended on 9th June 2006 (Amendment A) and 19th September 2006 (Amendment B), as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 40(4) of the Waste Management Acts 1996 to 2005.

Technical Amendment

In pursuance of the powers conferred on it by Section 42B(1)(c) of the Waste Management Acts 1996 to 2005, the Agency amends Licence Reg. No. W0213-01, granted to Roadstone Dublin Limited, Fortunestown, Tallaght, Dublin 24 to carry on an activity at Roadstone Dublin Remediation Facility, Dillonsdown, Deerpark, Newpaddocks and Santryhill Townlands, Blessington, County Wicklow.

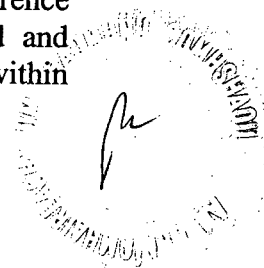
Henceforth, Waste Licence Register No. W0213-01 shall be read in conjunction with Amendments A and B in pursuance of Section 42B(1) of the Waste Management Acts 1996 to 2005, and the amendments set out below.

This technical amendment is limited to the following Condition of Licence Reg. No. W0213-01:

Amendments

- (1) Replace Condition 1.5 of Waste Licence Register W0213-01 (as amended) with the following:-

- 1.5 For the purposes of this licence, the facility authorised by this licence, is the area of land outlined or hatched in red on Drawing Reference: *Figure 1 – Waste Stockpile Areas/Revised Waste Licence Area*, dated May 2007, in correspondence received 24th May 2007. Any reference in this licence to “facility” shall mean the area thus outlined and hatched in red. The licensed activities shall be carried on only within the area outlined.




(2) Replace Condition 1.6.1 with the following:-

1.6.1 With the exception of emergencies or as may be agreed by the Agency, waste shall be despatched from the facility only between the hours of 0730 to 1800 Monday to Friday inclusive and 0800 to 1600 on Saturdays.

This technical amendment shall be cited as Amendment C (in pursuance of Section 42B(1) of the Waste Management Acts 1996 to 2005) to Waste Licence Register No.W0213-01.
