Following discussion, the Directors decided to grant a licence, as modified, to Greyhound Recycling and Recovery Limited, Crag Avenue, Clondalkin Industrial Estate, Clondalkin, County Dublin, Register of Licence No W0205-01, subject to conditions as set out in the licence document.

**Application for the authorisation of cultivation of GM Maize in the EU**

***Applicant: Pioneer Hi Bred International, Inc.***

The Directors considered documentation from the Office of Licensing and Guidance regarding an Application, under Regulation (EC) 1829/2003 on Genetically Modified Food and Feed, for authorisation of GM Maize (59122) (Ref GMO NL 2005-23) for cultivation in the EU. The Inspector's Report detailed the background to the Application, the implications for Ireland and who the EPA consulted regarding the Application. The OLG recommended that the EPA make certain comments in relation to the ERA part of the application, Ref: GMO NL 2005-23 (maize 59122) and that these comments be sent to the Department of the Environment, Heritage and Local Government for information. Following discussion and based on the information before them, the Directors approved the recommended comments as detailed in the Inspector's Report, dated 21 May 2007.
